Dear Mr. Jones:

Upon your request I assessed Michael Smith's current level of physical and cognitive functioning and developed a long-term care plan to identify the reasonable and expected costs associated with his case. His parents, doctors, and therapists assisted in this assessment by providing pertinent information. In this case the reference point was either a direct phone contact with the health care professional, vendor company representative, or from information presented in the medical record.

Michael's present condition and associated problems create special vocational, educational, medical, equipment, and service needs. The cost for these services and equipment are noted in my report. The cost figures presented are related to certain assumptions that are based on his current needs and past medical and developmental patterns. These figures are reflective of the 2003 market values.

Dear Mr. Jones:

The attached Medical Care Cost Summary reveals that the monies needed by Michael Smith for future health and medical care are \$8,302,656 to \$9,721,658 stated in terms of present value, based upon the range of treatment options and treatment costs of the underlying life care plan. This figure considers appropriate long-term and short-term rates of interest and medical care increases in the areas of commodities and services.

Table 1 examines the interrelationship over time between the rate of medical cost changes and the rate of interest. An inspection of the table reveals fluctuation over time. However, both long-term and short-term rates of increase in medical services have exceeded the rates of increase in medical and non-medical commodities over the same time frame. A present value calculation based on historical data assumes that a similar trend will persist in the future.

The current cost of the monies needed by Mr. Smith for future health and medical care is \$8,981,812 to \$10,452,974 stated in terms of 2003 dollars. This figure will be sufficient to meet his long-term health and medical care needs if it is assumed that the long-term rise in the cost of medical care and services will be offset by a conservative and safe investment, such as a 91-day Treasury bill.

One approach would make use of historical trends of a long-term and short-term nature, as appropriate, resulting in medical care costs of \$8,302,656 to \$9,721,658. Another approach to estimating future health and medical care costs for Mr. Smith would make use of a pure offset, and with such an approach, the present value of the dollar would be \$8,981,812 to \$10,452,974. Please advise if further information is desired.

DIAGNOSIS

C4 fracture with thirty to fifty percent spinal cord compromise; C3-C6 spinal fusion; spasticity, status post baclofen pump insertion; areflexic bladder secondary to injuries sustained in a motor vehicle accident.

MEDICAL CARE

Primary Care Physician: As a result of his neurologic impairments, Michael has experienced or is likely to experience additional complications. These include respiratory infections, contractures, skin breakdowns, and urinary tract infections. Therefore, he will need monitoring by this specialist to provide intervention, treatment, and referrals as needed.

Physiatrist: As a part of the ongoing monitoring of his physical and functional status, Michael requires follow-up with this specialist. This specialist also provides treatment for his spasticity and monitors and manages Michael's baclofen pump.

Urologist: As a result of his spinal cord injury, Michael has an areflexic bladder. He requires intermittent catheterizations for bladder management. Michael will continue to require follow-up with this specialist for management of his bladder and sexual impairments.

Psychologist: Michael sustained extremely traumatic and disabling injuries. Dr. John Black, his physiatrist, recommends periodic counseling for Michael to assist him in coping with the changes in his life and the long-term effects of his injuries.

Diagnostic Tests: Michael will require periodic blood tests to monitor his general medical status and the effects of his medications. He will also require periodic renal ultrasounds to monitor his urologic status.

Future Medical/Surgical Procedures: Michael recently had a baclofen pump inserted to assist in the management of his spasticity. This pump is checked and refilled approximately every three months and will need to be replaced periodically throughout his life expectancy. Michael also receives Botox injections for the spasticity in his upper extremities approximately every three months. Eventually, Michael may be a candidate for the NeuroControl FREEHAND System. This is an implanted device that would enable him to regain use of a paralyzed hand and improve his quality of life. According to Dr. Black, it is unknown at this time whether Michael will gain enough control, function, and mobility in his hand and arm to qualify for this device. Therefore, no costs for this procedure were included in this plan.

THERAPY AND TRANSPORTATION

Therapy: Michael currently receives physical, occupational, and aquatic therapy two times per week. His parents also assist him with a home exercise program. Dr. Black recommends that Michael continue this intensive therapy program for at least one year. To assist him in reaching his maximum level of functioning, Michael will continue to receive these therapies at decreasing frequencies over the next six years. After age 30, periodic evaluations by a licensed therapist are included to monitor Michael's functional status and to evaluate the need for any additional therapeutic interventions.

Transportation: Michael requires a wheelchair for mobility. An adapted van is required to transport him safely to and from all appointments and other activities. A cellular phone and roadside assistance have been included in case of a vehicular emergency.

HOME ASSISTANCE

Michael requires assistance with all activities of daily living including bathing, dressing, grooming, eating, elimination, and mobility. His parents currently provide this assistance to him. Michael will continue to require assistance throughout his life expectancy. This plan details alternatives to provide the long-term care that he will require. Alternative One plans for continued care to be provided by Michael's mother until he reaches the age of 41 (Mrs. Smith will be age 60). Home health care would then provide assistance to Michael in the home. In alternative Two, Michael would enter a supported living program at the age of 41. Respite care is also included for twelve to sixteen hours per week to assist Michael's mother in providing care for him.

HOME MODIFICATIONS

As a result of his injuries, Michael requires a wheelchair for mobility. Currently, he resides with his parents in a single-story home with a basement. A ramp has been built at the front entrance to the home. In November of 2002, a home evaluation was completed by Linda Fry, OTR/L, and John Hanson, AgrAbility Project Director. Their recommendations for home modifications include the installation of a second railing on the ramp, an automatic door opener, an environmental control unit, and a SureHands Lift System. They also recommended widening both the bedroom and bathroom doorways for easier access. However, Michael and his parents state that they have not experienced any difficulties with access through these doorways in his current wheelchair. Therefore, no costs were included for the widening of these doorways at this time.
